## Project “TOGETHER AGAINST VIOLENCE”



*The main activities are defined in 4 Workstreams:*

**WS-1** Research of the factors leading to repeated violence

**WS-2** Description and evaluation of the systems of services directed to support youngsters in conflict with the law

**WS-3** Formulating recommendations for the improvement of services for children, perpetrators of violence

**WS-4** Dissemination of the project results
